DIRECTIONS FOR USE

SELECT 2 EC HERBICIDE FOR ANNUAL AND PERENNIAL GRASS CONTROL IN KENAF WHEN GROWN AS A NON-FOOD/NON-FEED CROP.

SELECT 2 EC Herbicide	6.0 to 8.0 fl. oz./A	Annual Grasses: 6.0 fl. oz./A Perennial Grasses: 8.0 fl. oz./A Refer to SELECT 2 EC HERBICIDE label for grass weeds controlled and weed sizes.

Adjuvant: SELECT 2 EC Herbicide must be applied with a crop oil concentrate at 1.0% (v/v).

Use Restrictions for SELECT 2 EC Herbicide:

1. Always read and follow all label directions when using any pesticide.
2. Do not plant any crop for 30 days after application unless SELECT 2 EC Herbicide is registered for use in that crop.
3. Do not apply SELECT 2 EC Herbicide when grasses are under stress.
4. Do not apply SELECT 2 EC Herbicide through any type of irrigation system.
5. Do not apply SELECT 2 EC Herbicide if rain is expected within 1 hour of application.
6. Do not apply over 16 fl. oz./A of SELECT 2 EC Herbicide per growing season.
7. Do not graze treated crop nor use treated crop for food or animal feed purposes.

APPLICATION INFORMATION

For best results, SELECT 2 EC Herbicide should be applied to actively growing weeds.

Ground Application: Use of sufficient spray volume and pressure is essential to ensure complete coverage. Use a minimum of 10 gallons of spray solution per acre. Spray pressure should reflect a minimum of 40 psi and a maximum of 60 psi at the nozzle. Do not use flood, whirl chamber or controlled droplet applicator (CDA) nozzles for postemergence spray applications.

Follow all applicable directions, restrictions, and precautions on the EPA-registered labels.

This labeling must be in the possession of the user at the time of pesticide application.
