GENERAL INFORMATION

MICROMINOR™ can be used in combination with water soluble plant nutritional products which are formulated for foliar, sidedress or drip irrigation application. May be applied alone or in tank mixes containing fertilizers, fungicides and/or pesticides. **MICROMINOR** is believed to be compatible with most agricultural water-soluble plant nutritional products. If physical compatibility with another fertilizer product is unknown, use a jar compatibility test. The addition of calcium to the **MICROMINOR** blend is recommended. When applying **MICROMINOR** blend as a foliar spray, always use a spreader penetrant such as **Widespread® Max**.

ONCE PRODUCT IS DILUTED, USE WITHIN 24 HOURS

DIRECTIONS FOR USE

Citrus & Avocados: 1-4 quarts/per acre. Apply after first flush in spring. Repeat applications every 2-4 weeks as necessary.

Field & Vegetable Crops: 1-4 quarts/per acre. Begin applications when plants are 6-8 inches in size.

Deciduous Fruit & Nut Crops: 1-4 quarts/per acre. Apply as needed throughout the growth season.

Grapes & Berries: 1-4 quarts/per acre. Apply as needed during periods of active growth.

Turf: 0.5 to 1.0 fluid ounces per 1,000 sq. ft. Weekly applications as needed.

Ornamental Tree, shrubs and flowering plants: Apply at dilution rate of 3 ounces in 1 gallon of water. Spray to run off. Apply as needed at spray intervals of 14 days or more.

FIRST AID

If in eyes: Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

If swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice.
