**Cotton:** 4.0 to 8.0 ounces per 100 pounds seed

**Barley, Millet, Rice, Sorghum, Triticale and Wheat:** 4.0 to 6.0 ounces per 100 pounds seed

**Note:** Rhizobia inoculants are NOT compatible with AWAKEN<sup>®</sup> ST and should not be used with AWAKEN ST.
