4. FIRST AID MEASURES

4.1 Description of First Aid Measures

General Advice: Get medical attention if symptoms occur.

6. ACCIDENTAL RELEASE MEASURES

6.1 PERSONAL PRECAUTIONS, PROTECTIVE EQUIPMENT AND EMERGENCY PROCEDURES

Personal Precautions: Avoid inhalation of vapors and spray mist and contact with skin and eyes. Ensure adequate ventilation. Wear suitable protective clothing.

6.2 ENVIRONMENTAL PRECAUTIONS

Environmental Precautions: Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment washwaters or rinsate.

6.3 METHODS AND MATERIALS FOR CONTAINMENT AND CLEAN-UP

Methods for Clean-Up: Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb in vermiculite, dry sand or earth and place into containers. After removal flush contaminated area thoroughly with water. Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to Remove residual contamination. Never return spills to original containers for re-use.

7. HANDLING AND STORAGE

7.1 PRECAUTIONS FOR SAFE HANDLING:

Advice on Safe Handling: Avoid inhalation of mists, vapors / spray and contact with eyes, skin and clothing. Do not breathe mists or vapor. Wear personal protective equipment. Do not use in areas without adequate ventilation. Avoid prolonged exposure. Wash thoroughly after handling. Do not empty into drains. Handle and open container with care. Use care in handling/storage. Wash before eating, drinking and/or smoking.

7.2 CONDITIONS FOR SAFE STORAGE:

Requirements for Storage Areas and Containers: Store above 10 °F (-12.2 °C) to keep product from crystallizing. Crystals will settle to the bottom of the container. If allowed to crystallize, place in a warm room at 68 °F (20 °C) for several days to redissolve and roll or shake container or recirculate in mini-bulk or bulk containers to mix well before using. Do not contaminate water, foodstuffs, feed or seed by storage or disposal.

13.1 WASTE TREATMENT METHODS

PESTICIDE DISPOSAL: Wastes resulting from the use of this product that cannot be used or chemically reprocessed must be disposed of in a landfill approved for pesticide disposal or in accordance with applicable federal, state, or local procedures. Emptied container retains vapor and product residue. Observe all labeled safeguards until container is cleansed, reconditioned, or destroyed.

Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. **Pressure rinse as follows:** Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip. **For packages greater than 5 gallons and less than 56 gallons: Triple rinse as follows:** Empty the remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. **Pressure rinse as follows:** Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip. **For packages greater than 56 gallons:** To clean the container before final disposal, empty the remaining contents from this container into application equipment or mix tank. Fill the container about 10 percent full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two more times. **For refillable containers:** Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. To clean the container before final disposal, empty the remaining contents from this container into application equipment or mix tank. Fill the container about 10 percent full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two more times.
