P Max Ultra EZ-FLO is a phosphate fertilizer additive. When impregnated on dry phosphate fertilizers, **P Max Ultra EZ-FLO** increases phosphate efficiency, micronutrient availability and plant uptake. **P Max Ultra EZ-FLO** is biodegradable and safe to aquatic and terrestrial organisms.

P Max Ultra EZ-FLO is not a substitute for recommended phosphate fertilization based on crop removal rates or yield goals.

DIRECTIONS FOR USE

Impregnate **P Max Ultra EZ-FLO** onto dry phosphate fertilizer (e.g.: 0-46-0, 18-46-0, 11-52-0) during the receiving process as it is transferred into bulk storage or during the custom blending process.

Use Rate – 3 quarts/ton (2,000 lbs.) of phosphate fertilizer.

Application during custom blending operation:

When impregnating **P Max Ultra EZ-FLO** onto the dry phosphate fertilizer during the custom blending operation follow the steps below:

- 1.) Add phosphate fertilizer to blender.
- 2.) Impregnate with **P Max Ultra EZ-FLO** at 3 quarts/ton.
- 3.) Add additional fertilizer components to complete the blend.
