First Aid

If Swallowed: Rinse mouth. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person. If you feel unwell, call a poison control center or physician immediately for treatment advice.

If Inhaled: Move person to fresh air and keep at rest in a position comfortable for breathing. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. If you feel unwell, call a poison control center or physician for further treatment advice.

If on Skin or Clothing: Rinse skin immediately with plenty of soap and water for 15 to 20 minutes. If skin irritation occurs, get medical attention. Take off contaminated clothing and wash before reuse.

General Information

Hydro-Wet Fertilizer Concentrate is a high performance turf and soil wetting agent formulated for incorporation into dry fertilizers such as ground corn cob, montmorillonite minerals, vermiculite, peat and peat lite mixes and other soil media or inert carriers.

When incorporated onto a dry carrier, Hydro-Wet Fertilizer Concentrate will assist the management and conservation of water to ensure more uniform distribution and availability of water to the soil root zone.

Hydro-Wet Fertilizer Concentrate reduces watering requirements by minimizing soil repellency thereby reducing water evaporation and run-off.

Directions For Use

Always follow label instruction of any companion product that will be used with Hydro-Wet Fertilizer Concentrate.

For Dry Fertilizers or Inert Carriers: Always premix a small volume of Hydro-Wet Fertilizer Concentrate to dry material to determine adsorption rate of the liquid. Add 1 to 5 gallons of concentrate per 2,000 pounds of dry fertilizer or carrier. Hydro-Wet Fertilizer Concentrate can be slightly diluted with water (10% or less) and applied as a fine mist onto tumbling bed of dry material.

Hydro-Wet Fertilizer Concentrate should not be used in high heat conditions or near an open flame.

Tank Mixing

Tank mix combinations containing Hydro-Wet have not been tested under all growing conditions. Applicator should follow instructions of pesticide label to determine such use. Always exercise caution when using wetting agents with other commonly used turf chemicals and fertilizers. Test a limited turf area prior to large scale applications.

Storage, Disposal & Spill

Do not contaminate water, food or feed by storage or disposal of this product.

Storage: Store in a well-ventilated place. Keep cool. Store in a tightly closed container. Store in original container only.

Disposal: Triple pressure rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program. To contact your state and local ACRC recycler visit www.acrcycle.org. Dispose of contents/container in accordance with local/national regulations.
