LINK DESERT DEEP ROOT contains slow release nitrogen powered by NDemand® methylated urea, providing continuous feeding for up to 4 months. It also contains humic acid for stimulation of microbial activity in the soil. LINK DESERT DEEP ROOT is a non-abrasive, non-clogging fertilizer that needs no special agitation. LINK DESERT DEEP ROOT contains EDTA/IDS chelated micronutrients and no chlorides.

LINK products are formulated specifically for the professional market including greenhouse, field and container grown nursery, sports turf, and landscape maintenance managers. LINK DESERT DEEP ROOT should be used as part of a comprehensive Total Nutrition System® for optimizing plant growth, development and quality.

DIRECTIONS FOR USE

LINK DESERT DEEP ROOT should be injected in the top 4 to 8 inches of soil where feeder roots extend. Determine trunk diameter and inject 5 gallons of finished solution per inch of tree

diameter. Mix rate for deep root fertilizing should be 1-3/4 gallons per 100 gallons of water. Spacing of injection sites should be approximately 2-1/2 feet. Inject approximately 1/2 gallon of finished solution per hole; 1-3/4 gallons per 100 gallons of water equals 1/6 of a pound of nitrogen per inch diameter.

Foliar Turf Application: Apply 7-8 ounces per 1,000 square feet ever 7 to 14 days for trees and greens. Apply 17-34 ounces per 1,000 square feet every 4 to 8 weeks for turf/lawns.
