



## Supplemental Label Atrazine 4L

### TANK MIX WITH TEAMWORK™

FOR USE ON CORN AND GRAIN SORGHUM

Rate per Acre of Atrazine 4L	Rate per Acre of TEAMWORK	Acres covered by one 2.5 gal. Of Atrazine 4L and one 8 oz. Container of TEAMWORK	Directions For Use:
.83 Pint (13.3 oz.)	.33 oz	24	Fill tank $\frac{3}{4}$ full of water. Make sure the agitation system is operating. Mix in the required amount of TEAMWORK. After the product is thoroughly mixed, add the Atrazine 4L and continue agitation. If surfactant system is used, mix in last and agitate thoroughly.

#### SURFACTANTS

Use a nonionic surfactant, cleared for use on growing crops, having at least 80% active ingredient, such as Preference or Activate Plus at 0.25% v/v (2 pints per 100 gallons of spray solution).

#### TANK MIXTURES

Atrazine 4L plus Teamwork may be mixed with other herbicides to control weeds not listed on this label.

See the TEAMWORK and Atrazine labels for additional restrictions, precautions and use directions, following the most restrictive labeling in all cases. No label rates or dose can be exceeded.

For control of giant and common ragweeds, annual smartweeds, and wild sunflower:

Teamwork plus Atrazine 4L can be tank mixed with 2,4-D (amine), Sterling™, Banvel® or Clarity® herbicides. Add 2,4-D (amine) to the tank mix at 0.125 - 0.25 pound active ingredient per

acre or Sterling, Banvel or Clarity at 3-4 fluid ounces. per acre. Higher rates of Atrazine, Sterling, Banvel or Clarity herbicides can be used, but do not exceed the recommended label use rates allowed by these labels.
