BATALIUM HERBICIDE can be used at a reduced rate of 10.3 fl oz/A in spring wheat, including durum wheat, for soils with a pH of 7.8 or greater and if organic matter is less than 3%. **BATALIUM HERBICIDE** at a use rate of 10.3 fl oz/A can be tank-mixed fluroxypyr and bromoxynil to improve control of broadleaf weeds listed on the **BATALIUM HERBICIDE** label.
