#### Directions for Use

Applications made during periods of intense rainfall, to soils saturated with water, surfaces paved with materials such as asphalt or concrete, or soils through which rainfall will not readily penetrate may result in runoff and movement of Milestone VM. Injury to crops may result if treated soil is washed, or moved onto land used to produce crops. Exposure to Milestone VM may injure or kill susceptible crops and other plants, such as grapes, soybeans, tobacco, sensitive ornamentals. Do not treat frozen soil where runoff could damage sensitive plants.

Milestone VM provides preemergent and post emergent control of susceptible weeds. See the Milestone VM label for directions on use for post emergent applications.

Preemergent applications of Milestone VM can prevent weed germination and emergence. Apply Milestone VM as a preemergence spray before or during the rainy season when weeds are actively germinating. Control will depend upon species susceptibility, application timing, and environmental conditions, such as precipitation, following application.

For preemergent applications apply Milestone VM at 7 fl oz per acre. Best results for total vegetation control are obtained if Milestone VM is tank mixed with other herbicides to broaden the weed spectrum by controlling grasses. If grasses and tolerant broadleaf weeds are present on the site then tank mixtures with other herbicides, such as Accord XRT II, Accord Concentrate, Rodeo, Dimension 2EW, Oust XP, Payload, and diuron are recommended.

In addition to the plants listed on the Milestone VM label, the following weeds are controlled when Milestone VM is applied preemergence.
