APPLICATION RATES

Note: MARINER B is a highly effective formulation of Boron and requires much lower use rates than other Boron formulations.

DIRECTIONS FOR USE:

SOIL APPLICATION: Apply 1 - 4 PINTS per acre. Rate will depend upon level of deficiency. It is recommended that soil or tissue samples be performed to determine the deficiency.
FOLIAR APPLICATION: Apply alone or with other foliar sprays at a rate from 1-2 PINTS per acre. Rate will depend upon level of deficiency.

COMPATIBILITY

Do not combine with pesticides that have restrictions concerning liquid potassium fertilizers. MARINER HIGH K should not be mixed or applied with non-chelated nutrients such as calcium, copper, manganese, magnesium, iron or zinc compounds or antibiotics, sulfates, chloride salts or spray oil

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Triple rinse container. Empty rinsate into spray tank. Dispose of empty container according to approved local practices. Contact county agricultural commissioner for disposal information.

CAUTION: KEEP OUT OF REACH OF CHILDREN

If this product gets into eyes, wash with water for 15 minutes. If irritation persists, seek medical attention.
