### GENERAL INFORMATION

ProNatural® B is a water soluble and fertilizer soluble source of boron. It may be mixed and applied with fertilizers or pesticides on soil or foliage. ProNatural B is compatible with metal sulfates, such as zinc sulfate solution.

### DIRECTIONS FOR USE

**FOLIAR APPLICATIONS:** Use sufficient water for thorough coverage.

ProNatural B may be mixed with most pesticides. This product has a pH of approximately 5.0 with slight buffering capacity. ProNatural B will decrease the pH of a spray solution approximately 0.5 units at a rate of 5 pounds per 100 gallons of water. Multiple applications are preferred over a single application.

**SOIL APPLICATIONS:** ProNatural B may be applied to the soil with fertilizers or crop protection materials. ProNatural B may be mixed with dry fertilizers and certain liquid fertilizers.

**TREES AND VINES: Post-harvest and Dormant:** Apply no more than 8 pounds per acre with sufficient water for thorough coverage. Apply prior to bloom, either in the fall, dormant or delayed-dormant.

**Foliage:** Apply up to 5 pounds per acre with sufficient water for

through coverage. The number of applications is dependent upon the deficiency. **Soil:** Apply 3-10 pounds per acre, rate depends upon the deficiency. Apply with irrigation water, fertilizer, or pesticides.

**ROW, FIELD AND OTHER CROPS: Foliage:** Apply up to 3 pounds per acre with sufficient water for thorough coverage. The number of applications is dependent upon the deficiency. The maximum solubility is 3 pounds per 10 gallons of water. **Soil:** Apply 3-10 pounds per acre; rate depends upon the deficiency. Apply with irrigation water, fertilizer, or pesticide.

Always add PVA (water-soluble bags) materials and thoroughly dissolve before adding ProNatural B to the mixture. Sufficient agitation should be used when dissolving this product in water. Always jar test new combinations for compatibility prior to field mixing.
