#### Section 4 - First Aid Measures

<b>Eye contact:</b>	Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing. Call a poison control center or doctor for treatment advice.
<b>Skin contact:</b>	Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.
<b>Inhalation:</b>	No special requirements
<b>Ingestion:</b>	Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.
<b>Notes to physician:</b>	This product contains a cholinesterase inhibitor. Atropine is antidotal. 2-PAM may also be given in conjunction with Atropine. May pose an aspiration pneumonia hazard. Contains petroleum distillates.
<b>General advice:</b>	If you feel unwell, seek medical advice (show the label where possible). Ensure that medical personnel are aware of the material(s) involved, and take precautions to protect themselves. Keep out of reach of children.
