### 4. First-Aid Measures

#### Description of first aid measures

##### General advice:

A marked decrease in body weight gain and an increase in benign thyroid proliferative lesions were observed in the lifetime rat study at the highest dose tested. The substance is not considered to pose a carcinogenic risk at low human exposure levels.*

Despite its structure as both a nitro-compound and aromatic amine, exposure to pendimethalin is NOT associated with methemoglobinemia.
