GENERAL INFORMATION

TILL-IT® CONSTRUCT® is a liquid phosphate fertilizer designed as a starter or pop-up fertilizer. **TILL-IT CONSTRUCT** may be applied below, to the side or in the seed furrow of most crops depending on local conditions and established agricultural practices. **TILL-IT CONSTRUCT** contains fully chelated EDTA zinc as well as humic acid for enhanced phosphorus and micronutrient uptake.

DIRECTIONS FOR USE

Moisture conditions and planting strategy are important considerations when using **TILL-IT CONSTRUCT**.

POP-UP APPLICATIONS: Apply 1-5 gallons per planted acre on seed as established by local agricultural practices. **TILL-IT CONSTRUCT** may be diluted with water for ease of calibration if needed. When applied in the

seed furrow on dry soils, a post-plant irrigation within 24 hours is highly recommended. Direct application to the seed is discouraged in saline soils.

STARTER APPLICATIONS: Apply 2-10 gallons per acre as a band directly below the seed, or 10-20 gallons a minimum of 6 inches below the seed, or 10-20 gallons below and to the side of the seed line. **TILL-IT CONSTRUCT** may also be applied as a surface spray band over the top or to the side of the seed prior to planting.

COMPATIBILITY

TILL-IT CONSTRUCT is not compatible with acid fertilizers. Compatibility with other products may vary. Always jar test new combinations for compatibility prior to field mixing. Do not mix **TILL-IT CONSTRUCT** with calcium fertilizers.
