### DIRECTIONS FOR USE:

**Apply near bloom and continue throughout the growing season**  
**Stone Fruit, Nut Crops, Citrus & Olives:**

**Foliar:** 2-6 pts. per 100 gal  
**Soil:** 1/2—1 gpa pre-plant and early in the growing season

### Vine Crops:

**Foliar:** 2-6 pts per 100 gal  
**Soil:** 1/2—1 gpa pre-plant and early in the growing season

### Vegetable & Field Crops, Tropical

**Fruits & Berries:** *Note: For Berries consult a technical representative for late season/maturity rates*

**Foliar:** 2-6 pts per 100 gal applied from 3rd-4th leaf stages throughout the season.  
**Soil:** 1/2—1 gpa pre-plant and early in the growing season

### Ornamentals:

**Foliar:** 1/4-2 oz per gal applied throughout the growing season.  
**Soil:** 1-2 pts./1,000 sqft of planted area
