SUPER H.A. is formulated for field, vegetable, row, fruit, tree, vine, ornamental and turf crops.

SUPER H.A. may be applied through drip systems, aircraft, or via ground sprayers (high-volume or low-volume).

SUPER H.A. may be applied alone or with fertilizers or pesticides. It can be applied either to the plant foliage or to the soil.

SUPER H.A. is compatible with most pesticides and fertilizers. However, a compatibility test is recommended if the desired combination has not been used in the past. USE CAUTION WITH FERTILIZERS WITH AN EXTREMELY ACIDIC pH, AS THIS MAY CAUSE THE HUMIC FRACTION TO PRECIPITATE.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Follow proper procedures for the disposal of spray solutions. Rinse and dispose of empty container according to approved local practices.

DIRECTIONS FOR USE

All Crops:

Foliar Application:

Apply 1/2 to 1 Lb/acre mixed with foliar applied materials as needed on a 10-14 day schedule. Dilute at least 1:20 in water if applied alone. Avoid foliar applications of SUPER H.A. when plants are under stress due to lack of moisture.

Soil Application:

Apply 1-3 Lbs/acre (If may be water run, side dressed, mixed with soil applied liquid nutrients or sprayed directly on the soil. When sprayed or side dressed without mixing with other nutrients, SUPER H.A. DRY should be diluted in 3-10 gallons of water.

Applications With Nutrients:

Apply 1/2 Lb. up to 1 Lbs. of this product per acre mixed with the liquid nutrient. Add SUPER H.A. DRY to a partially filled tank.
