Nutrients contained in **LINK 4 IRON SP** are readily available when applied to plant foliage or directly to the soil.

**LINK 4 IRON SP** is designed primarily for foliar applications to prevent or correct micronutrient deficiencies in turf and a wide range of ornamental plants.

**LINK 4 IRON SP** should be used as part of a comprehensive Total Nutrition System® for optimizing plant growth, development and quality.

Application of **LINK 4 IRON SP** is a means of obtaining a quick response to needed plant nutrients and beneficial elements. Foliar applications of **LINK 4 IRON SP** may be particularly beneficial during periods of peak nutrient demand, for plants grown on soils having poor nutrient availability, for plants suffering from a weakened root system or for other plant stresses.

### DIRECTIONS FOR USE

**LINK 4 IRON SP** may be applied as a foliar spray, fertigation injection, drip irrigation, or hydroponics. Application rates are 5-10 pounds per acre every 3-4 weeks to maintain color and vibrancy.

**FOLIAR APPLICATIONS:** For foliar applications on ornamentals, mix 5-10 pounds of **LINK 4 IRON SP** per 100 gallons of water and spray to runoff.

**GREEN-UP LIQUID:** For use as a stand-alone, green-up liquid for plants and turf, initial application should be 10 pounds of **LINK 4 IRON SP** per acre. Make subsequent applications of 5 pounds per acre every 3-4 weeks to maintain color and vibrancy.

**TANK MIXING:** When tank mixing with fungicides, herbicides, growth regulators, surfactants, or flowable fertilizers, initial application should be 10 pounds per acre. Subsequent applications should be 5 pounds or less per acre based on frequency of other products in the tank mix.
