Apply Force to all seeded crops in-furrow at 8 ounces per acre or use as a foliar spray from 4 to 16 ounces per acre once crops enter the 2 to 3 leaf stage through harvest. For enhanced results, apply Force in combination with Stoller's More Power and Seed Power. On citrus and other fruiting perennials, apply force at 16 ounces per acre in a single application from July through January. Force can be used on the following Field Crops: alfalfa, asparagus, bean crops, canola, clover, corn, cotton, cruciferous crops, cucurbits, melons, milo, onion/ garlic, peanut, pepper, potato, rape (canola), rice, soybean, sugar beet, sugarcane, sunflower, tobacco, tomato, vegetable crops, wheat/barley/oat; or Fruit and Nut Crops: almond, apple, apricot, avocado, banana, berry crops, cherry, citrus, coffee, fig, filbert, grapes, hazelnut, oil palm, olive, persimmon, peach, pear, pecan, pistachio, plums/prunes, pomegranate, strawberry and walnut.
