DIRECTIONS FOR USE:

Apply nitrogen as needed based on soil and tissue analysis.

Each gal. contains 3.4 lbs of ammonium sulfate.

COMPATIBILITY

Chemurgic's ASC should be jar tested when using with new mixtures. Do not mix with other fertilizers without testing compatibility.

MIXING INSTRUCTIONS

Fill mixing tank half full with water. Add *Chemurgic's ASC* while agitating tank and adding the remaining water. If adding pesticide(s), add this product before adding the pesticide(s) to the mix.

STORAGE AND DISPOSAL Do not contaminate water, food or feed by storage or disposal.

PRODUCT STORAGE: Keep container closed in storage. Store only in original container. Do not store in mild steel. **Store away from incompatible materials.**
