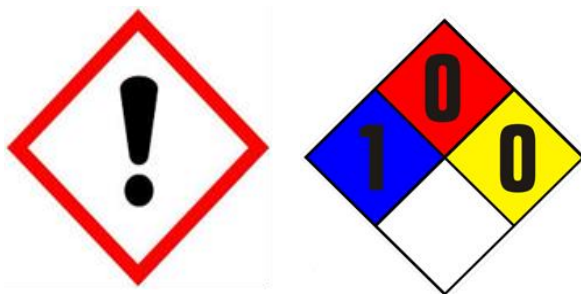


# DPG 17-0-0 – 8.8 Ca
