The coating agents in this product conform to US FDA Regulations in 21 CFR and European Union rules for fruit coatings.

PRINCIPAL INGREDIENTS: Ammonium hydroxide and proprietary food grade ingredients. Contains a rosin ester identified as a potential skin sensitizer.

DIRECTIONS FOR USE

1. Apply Natural Shine 9018 EU full strength over brushes to clean, dry fruit.
2. Use 1 gallon (3.8 liters) of Natural Shine 9018 EU per 8,000 - 12,000 lbs (3600 - 5400 kg) of fruit.
3. Apply using overhead spray or drip system over brushes having at least 50% horsehair to help spread the wax. Brush speed should not exceed 100 rpm.
4. White spots may develop in this coating from condensation when fruit is removed from cold storage.

NOTICE: Food & Drug Administration Act 403(i)(2) requires that fresh produce coated with this product be labeled "Coated with food grade vegetable and/or shellac based resin or wax" on bulk and individual retail/consumer packages. Fruit coated with this product should not be exported to Japan or other countries in which oxidized polyethylene is not approved for use in fruit coatings.

HANDLING: Causes eye irritation and mild skin irritation. Wear safety glasses, protective clothing and chemical resistant gloves when handling. Do not get in eyes or on skin. Wash hands thoroughly after handling.

STORAGE AND DISPOSAL: Store product in its original closed container in a dry and cool area. Avoid storing at temperatures below 40°F to keep product from freezing. Keep container closed and upright to prevent leakage and contamination. Use product during same season as when purchased. Disposal of contents/container should be made in accordance with applicable regional/national/ and local laws and regulations.

FIRST AID: IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention. IF ON SKIN: Wash with plenty of soap and water. If skin irritation occurs: Get medical advice/attention.
