GENERAL RECOMMENDATIONS

Opti-CAL® is designed to be applied as a post-harvest drench to apples and cherries.

HANDLING: Causes mild skin irritation and eye irritation. Wear safety glasses, protective clothing, and chemical resistant gloves when handling. Do not get in eyes or on skin. Wash hands thoroughly after handling. Harmful if swallowed. Do not smoke, drink, or eat when using this product.

FIRST AID: IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention. IF ON SKIN (OR HAIR): Wash with plenty of soap and water. If skin irritation or rash occurs: Get medical advice/attention. IF INHALED: Remove person to fresh air and keep comfortable for breathing. RECOMMENDATIONS FOR USE

TANK MIXES: Do not mix with pesticides or other fertilizers without compatibility test. To test for physical compatibility, mix the proper proportions of product with water and other ingredients, agitate and let stand for one hour. If a precipitate forms, apply the products separately.

MIXING: Fill drench tank with approximately half of needed water volume. Slowly add required amount of this product. Agitate continuously while adding remaining water and maintain agitation until application is completed.

POST-HARVEST DRENCH, APPLES, CHERRIES - Apply this product only to high quality fruit with intact skins. Application of this product to fruit of low quality may result in damage by calcium chloride. **Use rate:** Up to 2100 ppm calcium (up to 1 part Opti-CAL per 74 parts water) in a drench solution. Treat fruit immediately after harvest with drench solutions at the same temperature as the fruit to be treated. Use 500 gallons (1893 liters) of drench solution to treat up to 100 tons (90,700 kg) of fruit. Drench fruit for 30 to 60 seconds, then allow solution to drain from fruit.

Do not use bin liners.

Do not combine ethoxyquin with Opti-CAL as fruit damage may occur.

Do not mix Opti-CAL with other products unless safety and compatibility have been established.

STORAGE AND DISPOSAL

Keep in a cool, dry place out of reach of children and livestock. Protect from frost. Toxic to aquatic life: Keep container upright to prevent leakage and avoid release into the environment.
