DIRECTIONS FOR USE

PacRite 505-15 is a concentrated wax formulation designed to provide high shrinkage control of citrus fruit during the degreening process. This product must be diluted prior to use and applied as a spray over moving brushes. The dilution ratio varies with fruit quality and duration of storage period. Consult your PACE technical representative for proper dilution for application being used or usage on additional commodities. Use entire contents within 120 days after opening.

NOTICE: Food & Drug Administration Act 403(i)(2) requires that fresh produce coated with this product be labeled "Coated with food grade vegetable and/or shellac based resin or wax" on bulk and individual retail/consumer packages.

HANDLING: Causes mild skin irritation and serious eye irritation. Wear safety glasses, protective clothing, and chemical resistant gloves when handling. Do not get in eyes or on skin. Wash hands thoroughly after handling..
