MIXING INSTRUCTIONS

PLANT PLUS™ disperses well in fertilizer and water with minimum agitation. A fine precipitate may form in the container bottom. Shake well before using.

**Not all Actagro® products are compatible with one another or when mixed with other fertilizers and/or pesticides on the market. A small scale compatibility test is recommended prior to mixing.*

DIRECTIONS FOR USE

PLANT PLUS™ may be soil applied alone or in combination with liquid fertilizers. Band injections into moist soil or application through a drip irrigation system. May be applied through center pivot irrigations systems.

Mixing with irrigation water for field storage is generally not recommended. Products blended with irrigation water should be used immediately and not stored for prolonged periods.

SOIL APPLICATION RATES

COTTON: Inject into moist soil at 1/2 to 1 gallon per acre with UAN 32 or with water. Apply when the plants are 2 to 4 inches high and prior to irrigation. For soils with a CEC less than 20, apply 1/2 to 1 gallon per acre. For soils with a CEC greater than 20, apply 1 to 2 gallons per acre. Inject the material 4 to 6 inches to the side of the plant row. Use 10 to 30 gallons of water and/or fertilizer per acre with PLANT PLUS™.

GRAPES AND BERRY CROPS: Use 1/4 to 1 gallon per acre prior to bud break or early in the spring.

CITRUS, OLIVES, ALMONDS, PISTACHIOS AND DECIDUOUS TREE CROPS: Inject directly into the root zone and into moist soil. Inject at least one week prior to irrigation. To apply alone, dilute with a minimum of 10 to 15 gallons of water per acre to ensure uniform distribution. Drip irrigation systems can also be used to apply PLANT PLUS™ into the active root zones of trees. For deciduous fruit and nuts, olives and citrus, apply 1 to 2 gallons per acre at least 2 to 3 weeks prior to bud break in early spring.

VEGETABLES: Apply 1/2 to 1 gallon per acre during sidedress applications or through drip irrigation.

APPLICATION THROUGH DRIP IRRIGATION - inject after irrigation filter.

GENERAL INFORMATION

PLANT PLUS™ is manufactured for direct soil use on cotton, grapes, citrus, deciduous tree crops and vegetables. It may be combined with most soil applied liquid fertilizers. It contains Actagro Organic Acids® which may aid in soil applied micronutrient availability.

PLANT PLUS™ should be injected directly into the root zone and into moist soil. It should be injected at least one week prior to irrigation. Drip irrigation systems can be used to apply PLANT PLUS™ into the active root zone.

PLANT PLUS™ should be applied early in the crop's life cycle. Timing and placement of the material are extremely important.

PLANT PLUS™ is non-phytotoxic when used as directed.
