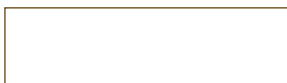

DIRECTIONS FOR USE:

TREND-90 recommendations varies as necessary to achieve a smooth uniform film. Use only the minimum amount to get the desired effect.

USAGE OF TREND-90:

Tree fruits, Nuts, Vineyards, Vine Crop and Field and Row Crops.

Use for dilute full volume sprays:

Regular use 8 to 16 oz. per 100 gallons (moderate easy to wet plants).

SUGGESTIONS FOR USE:

Rates Per 100 Gallons or Less of Spray Mix Per Acre:

HERBICIDES:

Use 1 to 3 pints (16 to 48 fl. oz.)

INSECTICIDES:

Use 1/2 to 1 pint (8 to 16 fl. oz.)

FUNGICIDES & ACARICIDES:

Use 1/2 to 1 pint (8 to 16 fl. oz.)

DEFOLIANTS & DESICCANTS:

Use 1 to 4 pints (16 to 64 fl. oz.)

STORAGE AND DISPOSAL:

Do not contaminate water, food or feed by storage or disposal. Follow all recommended governmental procedures for disposal of pesticide spray solution.

Triple rinse container, empty residue into spray tank. Contact county agricultural commissioner for container disposal information.
