### DIRECTIONS FOR USE:

**Apply ahead of, during, and shortly following bloom and throughout the growing season.**

#### Stone Fruit & Nut Crops:

Soil: 1/2 to 1 gpa  
Foliar: 1-4 pts/100 gals

#### Citrus & Olives:

Soil: 1/2 to 1 gpa  
Foliar: 1-4 pts/100 gals

#### Vine Crops:

Soil: 1/2 to 1 gpa  
Foliar: 1-4 pts/100 gals.

#### Vegetable, Field Crops, Tropical Fruits and Berries:

Soil: 1/2 to 1 gpa  
Foliar: 1-4 pts /100 gals applied from 3<sup>rd</sup>-4<sup>th</sup> leaf stages throughout the season.

#### Ornamentals:

Soil: 1/2 pt—1 pt/1000 sqft  
Foliar: ¼-2 oz/gal
