STATEMENT OF PRACTICAL TREATMENT

- If Swallowed:** Give a large amount of water to drink and induce vomiting. Seek medical attention immediately.
If Inhaled: Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen.
If In Eyes: Flush with water for 15 minutes. Seek medical attention immediately.
If On Skin: Wash skin contact area with plenty of soap and water for 15 minutes.

GENERAL INFORMATION—FS MaxSupreme is a liquid activator adjuvant specifically formulated to maximize pesticide performance on a wider range of weed species by reducing spray particle bounce; thus providing enhanced adhesion of the spray solution to the leaf surface, while providing the required amount of ammonium and sulfate ions.

FOR USE WITH PESTICIDES REGISTERED FOR AGRICULTURAL, FORESTRY, INDUSTRIAL, MUNICIPAL, NON-CROPLAND, RIGHTS-OF-WAY, TURF AND OTHER APPROPRIATE USES.

DIRECTIONS FOR USE—The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. Before using FS MaxSupreme, the applicator or crops advisor must have experience with the pesticide combination, including FS MaxSupreme, or must have conducted a phytotoxicity test.

APPLICATION RATES

- Ground Application:** 2.5% v/v (2.5 gallons) of FS MaxSupreme per 100 gallons of spray solution
Aerial Application: 2.5–5% v/v (2.5–5 gallons) of FS MaxSupreme per 100 gallons of spray solution
FS MaxSupreme provides 8.5 pounds of dry ammonium sulfate per 2.5 gallons

MIXING INSTRUCTIONS—Always mix this product in accordance with the instructions found on the pesticide label concerning adjuvants. In the absence of specific mixing instructions, fill the spray tank 1/2 to 3/4 full of desired water volume. While the water is agitating, add tank mix ingredients in the following order:

1. FS MaxSupreme.
2. Water-soluble packets, dry flowables and dispersible granules.
3. Flowables.
4. Water-soluble pesticides.
5. Emulsifiable concentrates.
6. Continue agitation and finish filling spray tank to desired level.
7. Add additional adjuvants.

STORAGE AND DISPOSAL—Keep container closed tightly when not in use. Prevent water from being introduced to the contents of this container. Protect product from freezing. Store in original container only and do not reuse empty container. Rinse container thoroughly, disposing of rinsate and the containers in accordance with federal, state and local regulations.
