## GENERAL INFORMATION

BRANDT CITRIC products are citric acid chelated micro nutrient fertilizer solutions for use in balanced nutritional programs. BRANDT CITRIC products are primarily designed for soil applications.

### Soil Application

**Row, Band or Side-dress:** Use 1-4 quarts BRANDT CITRIC GENERAL CROP MIX per acre. BRANDT CITRIC GENERAL CROP MIX is compatible with many polyphosphate starter solutions such as 10-34-0 and 11-37-0 and can be applied at time of planting.

*BRANDT CITRIC GENERAL CROP MIX may effectively be applied with most polyphosphate N-P-K starter solutions. For unfamiliar tank mix combinations sufficient evaluation to determine efficacy and crop safety may be warranted. A jar test is a good field practice for evaluating compatibility within a spray tank of multiple chemical mixtures. Optimum rate of application will vary depending on your soil properties such as soil pH, organic matter content, soil texture, weather conditions, time of year, general crop health and species. For best results, follow soil test or plant analysis recommendation.*

## Mixing Instructions

**Starter Fertilizer:** BRANDT CITRIC GENERAL CROP MIX may be mixed with most polyphosphate based starters, such as 10-34-0 and 11-37-0. Mix solution well to ensure complete and even dispersion. **CAUTION:** It is not intended for BRANDT CITRIC GENERAL CROP MIX to be mixed with orthophosphate solutions.
