GENERAL INFORMATION

BWC SPREADER-90 is a high analysis spreader-activator which gives quick wetting, absorption and aids in assimilation and translocation. BWC SPREADER-90 is low foaming, nonionic, and is 90% active. It can be used with insecticides, miticides, herbicides, defoliant and fungicides.

DIRECTIONS FOR USE

This product may be used in dilute or concentrate sprays. Rates Per 100 Gallons or Less of Spray Mix Per Acre for Acaracides, Insecticides and Fungicides: Aerial application; 4-10 ounces; ground sprayers; 4 ounces; Herbicides and Defoliant: 1-4 pints. Add BWC SPREADER-90 to spray tank first.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Follow all recommended governmental procedures for disposal of pesticide spray solutions. Triple rinse container, empty rinsate and spray tank. Contact county agricultural commissioner for container disposal information.
