COMPATIBILITY

FURST LIQUID is believed to be compatible with most agricultural foliar nutrients, spray adjuvants, fungicides, herbicides, and insecticides. If tank mixing, a simple jar test should be conducted to test for compatibility. Mixing with certain other compounds could result in an incompatible mix.
