POTTING SOIL & MULCHES:

Apply at a concentration of 0.05-0.1% (6-16 fl.oz. / 100 gallons water).

DUST SUPPRESSION:

To improve the efficiency of water applied to dirt roads and/or for pre-watering prior to application of dust control products, add Perc-O-Late at a rate of ½ to 1 gallon per 1,000 gallons of water.

GOLF COURSES & TURF:

Apply 8-16 fl.oz./1,000 sq.ft. in sufficient water for thorough coverage, then water in. Repeat as needed. Perc-O-Late can also be injected through the irrigation system on a weekly basis. Adjust proportioner valve to inject at the 1:1000 ratio.
