GENERAL INFORMATION

SIR-Factant is a general purpose non-ionic surfactant of the alkylaryl polyethoxyethanol type surface active agents. It can be used with most insecticides, fungicides, herbicides, acaricides, defoliant, desiccants and wettable powders to improve performance of the active spray ingredient by giving them more uniform distribution and better wetting of the plant surface.

MIXING INSTRUCTIONS

For wettable powders and water soluble materials, add this product in water before adding pesticide to spray tank. For emulsifiable products, add this product after a good emulsion is formed.
