**GENERAL:** DISPATCH AMS is an aqueous ammonium sulfate combined with a surfactant to provide a convenient adjuvant. DISPATCH AMS should be utilized with agricultural chemicals which require the addition of surfactant and ammonium sulfate.

**DIRECTIONS FOR USE:** Fill spray tank 1/2 full of water and begin agitation. Add desired amount of DISPATCH AMS to spray tank before adding agricultural chemicals which are susceptible to being complexed with cations (Ca, Mg, Fe) in hard water. Add pesticides, as directed by label, while maintaining agitation. Always add DISPATCH AMS to water before pesticides.

### SUGGESTED USE RATE - 10 GPA spray volume:

**1 to 2 quarts per acre DISPATCH AMS or 2.5 to 5 gallons per 100 gallons**

2.5 gallons of DISPATCH AMS per 100 gallons will supply 0.5% (2 quarts per 100 gallons) surfactant and a source of ammonium sulfate.

### STORAGE AND DISPOSAL

**STORAGE:** Store in a cool, dry place. Store in original container. Keep container tightly closed. Do not reuse empty container. Freezing will not harm product.

**DISPOSAL:** Do not contaminate water, food or feed by storage or disposal. Dispose of contents/container on-site or at an approved waste disposal facility. Triple rinse (or equivalent) adding rinse water to spray tank. Offer container for recycling or dispose of in sanitary landfill or by other procedures approved by appropriate authorities. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
