

CORE LIQUID ZINC 10%

For Soil Application. For correction or prevention of ZINC deficiency in most crops.



General Information

CORE LIQUID ZINC 10% is an effective and readily available liquid zinc source for soil application, for use on a wide range of crops and growing conditions.

Directions for Use

CORE LIQUID ZINC 10% is compatible with most pesticides as well as APP or liquid N fertilizers commonly used in "2x2" placement as starter fertilizer. Apply with sufficient carrier to give complete and thorough coverage. For optimum performance, zinc must be moved into the plant root zone in order to be absorbed by the plant. This can be accomplished by irrigation, rainfall, or tillage. Do not allow CORE LIQUID ZINC 10% to come in direct contact with seed at any time. CORE LIQUID ZINC 10% may be added in any ratio with 28% and 32% nitrogen solutions. Do not exceed a Phosphate:Zinc ratio of 15:1 when mixing with high polyphosphate fertilizer grades (i.e 7-21-7) or 10:1 ratio (i.e 10-34-0). Always conduct a jar test with new tank.

NOT FOR FOLIAR APPLICATION OR USE IN ORTHOPHOSPHATES.

Recommended Rates

The optimum rate and timing of application will depend on local conditions and should always be made as a result of soil and/or plant tissue analysis in consultation with your local agricultural authorities. In the absence of test results, use the following as a guide:

Broadcast or Band Applications:

Severe deficiency	6-12 pt/ac
Slight deficiency.....	2-4 pt/ac
Band.....	2-4 pt.ac

Caution: Check compatibility with orthophosphate fertilizers and other chemical prior to mixing.
