GENERAL INFORMATION

Zeba® is a biodegradable, non-toxic,
starch-based superabsorbent polymer. It is
designed to rapidly absorb and maintain
moisture in the root zone, releasing moisture
to plants as needed.

STORAGE INSTRUCTIONS

Zeba can be stored and shipped in
fiberboard, plastic container, or poly-lined
bag. Maintain product under dry storage
conditions.

USE DIRECTIONS

Agricultural Crops

Apply Zeba 4-6 inches [10-15 cm] below the
soil surface in proximity to root zone at a rate
of 3-10 lbs. per acre [3.5-11 Kg per hectare].
Use higher rates of 7-10 lbs. per acre [7.5-11 Kg
per hectare] in soil with low moisture holding
capacity for optimal moisture retention. See
your crop advisor for optimal rate in your
crop and soil type. Also see Zeba User Guide

Newly Planted Trees

For new plantings, use 1 Tbsp.- 2 Tbsp. per
tree. Place half the Zeba in the planting hole
and mix the remaining half in the backfill soil.

Anti-Crustant

As an anti-crustant, to aid in germination and
stand establishment, band directly over the
seed row before the press wheel. Apply at
2-4 lbs of Zeba per acre [2.5-5 Kg of Zeba per
hectare].
