#### FIRST AID

#### ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish and aquatic invertebrates and may contaminate water through runoff. This product has a potential for runoff for several months or more after application. Poorly draining soils and soils with shallow water tables are more prone to produce runoff that contains this product. Drift and runoff may be hazardous to aquatic organisms in water adjacent to treated area. Do not apply directly to water, to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment wash water or rinsate.

#### PHYSICAL HAZARDS

Sulfur dust suspended in air ignites easily. Keep away from heat, sparks, or flames. Do not smoke while applying this product.

#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

#### DRIFT MANAGEMENT

A variety of factors including weather conditions (e.g., wind direction, wind speed, temperature, relative humidity) and method of application can influence pesticide drift. The applicator must evaluate all factors and make appropriate adjustments when applying this product.

**Wind Speed:** Do not apply at wind speeds greater than 15 mph. Only apply this product if the wind direction favors on-target deposition (approximately 3-10 mph) and there are no sensitive areas within 250 feet downwind.

**Temperature Inversions:** If applying at wind speeds less than 3 mph, the applicator must determine if (a) conditions of temperature inversions exist, or (b) stable atmospheric conditions exist at or below application height. Do not make applications into areas of temperature inversions or stable atmospheric conditions.

**State and Local Requirements:** The following conditions must be followed when using this product in the state of California for both ground and air applications:

1. The operator of the property and the applicator must establish a buffer zone of enough distance to prevent drift onto non-target areas such as hospitals, clinics, schools, residential areas and any other area designated by the county agricultural commissioner.

2. The operator of the property and the applicator must evaluate the method and equipment for each site to ensure proper and safe use. Evaluations shall include, but not limited to the appropriateness of ground or air applications.

3. Sulfur shall not be applied when the wind velocity exceeds 10 m.p.h. Applicators should be aware that in some areas, "dead calm" conditions are often associated with an inversion situation. In these areas, applying sulfur when there is a minimum air movement of 2 miles per hour will ensure that an inversion situation does not exist.

4. When applying product, best application practices should be utilized. Contact your local pest control advisor or county cooperative extension advisor to obtain information regarding best application practices.

#### AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Workers Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

Do not enter or allow worker entry into treated areas during the restricted entry interval (REI) of 48 hours.

#### GENERAL INFORMATION

Apply recommended amounts when air is calm, using ground equipment, aircraft, or hand duster. Applications of material containing sulfur should not be made just prior to or during periods of high summer temperatures. Concord and other Labrusca type grapes may be injured by sulfur. Consult your local Agricultural Extension Service for additional information consistent with directions on this label. Do not mix or dilute with other products. Thorough coverage is essential.

**GRAPES: Powdery mildew, Bunch rots** - Use 20-25 lbs. per acre. Apply when grapes start to touch. Repeat at 3 to 10 day intervals. Applications must be applied before the disease appears. Do not apply more than 225 lbs of product/A/year. The maximum annual application of metallic copper is 20 lbs per acre per year.
