RNA ACTIVATOR 85<sup>®</sup> is a nonionic general purpose spreader-activator for use on all plants to improve the effectiveness of insecticides, herbicides and fungicides. This product provides more uniform leaf coverage without excess run-off spray on the leaf surface and enhances the effectiveness of insecticides, herbicides and fungicides.

### DIRECTIONS FOR USE

For insecticides, herbicides and fungicides use ½ -1 pint per each 100 gallons of finished spray solution. (In some cases as much as 2 quarts per 100 gallons will be recommended). **Some pesticides may require higher rates of RNA ACTIVATOR 85 for optimum performance. However, do not add this product at a rate which exceeds 5% of the finished spray volume. Follow pesticide label directions when this occurs.** Always add RNA ACTIVATOR 85 to the spray tank as the last ingredient with agitator running.
