PRECAUTIONARY STATEMENTS FIRST AID

If on Skin or clothing: Take off contaminated clothing. Rinse immediately with plenty of water for 15-20 minutes. Required rubber gloves.

If Inhaled: Move person to fresh air. If person not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible.

Low volume ground and aerial application 1 pint-2 quarts per acre. **Aquatic-submerged:** high volume ground application 1-2 gallons per 100 gallons or acre. Low volume ground and aerial application 1-2 gallons per acre.
