

## PRECAUTIONARY STATEMENTS

### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

## DIRECTIONS FOR USE

NO FOAM ADJUVANT may be used to increase the efficiency of acaricides, defoliants, desiccants, fungicides, herbicides and insecticides. This product insures quick wetting and uniform coverage that is beneficial to the performance of translocated and systemic chemicals. It may be used on agricultural, forestry, turf and ornamental, industrial, structural and non-cropland sites. NO FOAM ADJUVANT is formulated from raw materials which will not tend to burn foliage or leave harmful residues. There will be no excessive foaming when high pressures are used.

Read and follow the precautions, restrictions and recommendations on the labels of pesticides used with NO FOAM ADJUVANT. Use according to the most restrictive label directions for each product in any tank mix.

**COMPATIBILITY:** NO FOAM ADJUVANT is compatible with most pesticides. However, if the desired combination has not been previously used, a compatibility test is recommended.

**MIXING:** Shake well before using. Fill spray tank ½ full of water and begin agitation. Add the recommended amount of NO FOAM ADJUVANT. Add products as directed by label or in the following sequence and continue filling tank: (1) Dry flowables or water dispersing granules, (2) Wettable powders, (3) Flowables, (4) Solutions, (5) Emulsifiable concentrates. Continue agitation until spray solution is completely mixed. Continuous agitation of finished spray is recommended. If spray solution has been allowed to stand, thoroughly agitate and remix before application.

**RECOMMENDATIONS:** Specific use rates will vary with conditions of application such as water hardness, application method, equipment, spray droplet size, condition of foliage, etc. Also, higher rates than those below may be used if recommended by pesticide labeling. Follow pesticide label directions. However, do not add this product at a rate which exceeds 5% of the finished spray volume.

**AIR or GROUND:** Use ½-3 pints per 100 gallons of finished spray solution. For improved efficacy, use at least ½ pint per acre when finished spray volume is less than 20 gallons per acre. For backpack or hand held sprayers, use 1 fl. oz. per gallon of finished spray solution.

### STORAGE AND DISPOSAL

DO NOT CONTAMINATE WATER, FOOD OR FEED  
BY STORAGE OR DISPOSAL.

**STORAGE:** Store in original container away from children, animals, foods, feeds and seeds. Handle in accordance with Precautionary Statements. In the event of spillage or leakage, soak up the material with absorbent clay, sand, sawdust or other absorbent material. Scrape up and dispose in accordance with Product Disposal.

**PRODUCT DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. **CONTAINER DISPOSAL:** Triple rinse (or equivalent) during mixing and loading.
