### GENERAL INFORMATION

**SAFEGUARD** Adjuvant for Rice is a non-ionic surfactant with spreader-sticker properties specially formulated for use with **HARBINGER**® Herbicide in pre-flush, pre-rice germination, dry seeded or drilled rice. This bicyclic terpene compound provides a level of protection to rice plants from herbicide phytotoxicity when applied to dry seeded or drilled rice in combination with **HARBINGER** Herbicide.

### MIXING

Fill spray tank 1/2 full with water and begin agitation. Add **HARBINGER** Herbicide as directed by the label and continue filling. Add **SAFEGUARD** Adjuvant for Rice last and continue agitation.

### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Do not apply this product through any type of irrigation system. <b>SAFEGUARD</b> Adjuvant for Rice .....	1.6 to 2 pints
