² **Imported Fire Ants:** Control will be optimized by combining broadcast applications that will control foraging workers and newly mated fly-in queens with mound treatments (using Talstar GC Flowable) that will eliminate existing colonies.

³ The higher application rate may be required to control Ants, Centipedes, Chinch Bugs, Fleas, Imported Fire Ants, Millipedes, Mole Crickets & Ticks.
