Hydra-Hume® DG "Coated" is a leonardite mix, rich in humic acids containing perhaps the highest concentration of humic acids available from raw leonardite.

Products containing humic acids, such as Hydra-Hume® DG "Coated", may increase uptake of micronutrients.

**SUGGESTED DIRECTIONS**

Hydra-Hume® DG "Coated" can be applied to all crops including: vegetable crops, row crops, field crops, manure lagoons/pits, trees and vines.

Apply 10-40 pounds per acre per year. May be applied anytime during the year. First preference would be to broadcast in the fall after deep tillage. Second preference is to broadcast pre-plant up to first blossom.
