**CROP-SURF®** increases the activity of pesticides and, therefore, care should be exercised when pesticide spray containing **CROP-SURF®** is applied to new varieties or highly inbred lines not previously treated with spray adjuvants. Care is recommended when sprays are applied under very hot, humid conditions or under circumstances when pesticides tend to be more active. In new uses, it is recommended that small test areas be treated before undertaking large scale applications.

**MIXING** – Fill spray tank 1/2 full, add desired amount of pesticide and continue filling. Add the **CROP-SURF®** last. After filling continue agitation.
