MIXING INSTRUCTIONS

1. Partially fill tank with water and start agitation.
2. Add other nutrients or pesticides.
3. Add Monarch® to circulating tank mix.
4. Fill tank and agitate thoroughly.

DIRECTIONS FOR USE

Monarch® can be applied to most vegetable and cucurbit crops, field crops, row crops, deciduous fruit and nut trees, grapes, berries, olives, avocados and citrus. Monarch® may be used as a pop-up in furrow at 1 to 3 gallons per acre. Mixing with irrigation water for field storage is generally not recommended. Products blended with irrigation water should be used immediately and not stored for prolonged periods. Monarch® is non-phytotoxic when used as directed and is compatible with most commonly used pesticides and fertilizers.

FOLIAR APPLICATION RATES

FIELD & ROW CROPS, ORCHARDS & VINEYARDS, VEGETABLE & FRUIT CROPS: Apply 1/4 to 2 gallons per acre in enough water for thorough coverage. The maximum recommended concentration of Actagro Monarch® to water is 1:5.

VEGETABLES AND LEAFY CROPS: Apply 1/4 to 2 gallons per acre in a minimum of 5 gallons of water per acre. Repeat applications are beneficial.

SOIL APPLICATION RATES

Monarch® may be applied pre-plant, as a starter, side dress, fertigated, top dressed or banded to the soil. To apply alone, may be diluted with water to ensure uniform distribution.

VEGETABLES & FRUIT CROPS, ROW CROPS & FIELD CROPS: Apply 5 to 30 gallons per acre in a surface or sub-surface band. Repeat applications are beneficial.

ORCHARDS & VINEYARDS: Inject 5 to 30 gallons per acre 3 to 5 inches deep at the drip line, or surface band and water into the soil. Repeat applications are beneficial.

TRANSPLANT WATER - FIELD & ROW CROPS, ORCHARDS & VINEYARDS, VEGETABLE & FRUIT CROPS: Apply 1 to 8 gallons per acre in a minimum of 100 gallons solution, not to exceed a 3% Monarch® to water solution.

FERTIGATION APPLICATION RATES

FIELD & ROW CROPS, ORCHARDS & VINEYARDS, VEGETABLE & FRUIT CROPS: Use 1 to 20 gallons per acre per irrigation. Continue irrigation for a minimum of 2 hours after application to maximize fertilizer distribution. Repeat applications are beneficial.

APPLICATION THROUGH DRIP IRRIGATION - inject after irrigation filter.

GENERAL INFORMATION

Monarch® contains available phosphate and potassium. These nutrients are combined with a percentage of nitrogen to stimulate growth, fruit set and allow for a strong and vigorous plant structure.

Monarch® should not be applied to plants that are stressed by high temperature or lack of moisture. Optimum spraying conditions typically exist during early morning or late evening hours.

CAUTION: Always check compatibility with other products prior to use. Do not mix with conventional products containing the salts of heavy metals. Do not mix with conventional calcium based fertilizers.

CAUTION: Foliar application of Monarch® close to harvest may leave a brown residue on the harvestable portion of the crop. Rainfall, sprinkler irrigation or high humidity should alleviate this condition.
