PRODUCT INFORMATION

DYNA-Flo Humic Acid is a highly effective potassium humate for use in applications requiring root growth stimulation and promoting healthy soil under high stress growing conditions. This humate completely dissolves when added directly to fertilizers, micronutrients, or pesticides formulations of any pH. It allows the user to apply direct to tank mix, drip irrigation or acid soil applications unacceptable for conventional products.

APPLICATION RATES

Apply 2-4 quarts per acre in sufficient water. Do not apply over 5 gallons per acre per crop year.

Crops: Apply 3 quarts in 100 gallons of water per acre per application as needed.

Turf grass, Greens, Tees and Fairways: Apply 1-2 oz. per 1000 sq. ft. per gallon of water. Apply 1 to 1½ gallons in one hundred gallons of water per acre. In Florida, application rates should not exceed the recommendations in "BMP's for the Enhancement of Environmental Quality on Florida Golf Courses" found at www.dep.state.fl.us/water/nonpoint/pubs.htm
