## Liquid Foliar Spray

### PRODUCT INFORMATION

**Dyna Gold MZ** liquid foliar spray is a liquid foliar formulation designed for maximum uptake of zinc and manganese and should correct and prevent deficiencies in most tree crops. If added to the spray tank first, it will aid in lowering water pH. A jar test to check the compatibilities of new or unfamiliar combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant and / or urea nitrogen will aid in uptake.

### CROP RECOMMENDATIONS

**Citrus and Fruit Crops:** Mature trees: Use 2-3 quarts per acre per application in enough water to cover but not to run off. Repeat applications in summer and fall sprays as needed. **DO NOT USE ON STONE FRUITS.**

**Young trees:** Use 2 quarts per 100 gallons of water and cover leaf surface thoroughly but not run off.

**Pecans:** Use 2-3 quarts per acre in enough water to allow for thorough coverage but not to run off.

### DIRECTIONS FOR USE

**Dyna Gold MZ** liquid foliar spray should be applied at 2-3 quarts per acre in enough water to cover.

**Aerial applications:** 1-2 quarts per acre in a minimum of 5 gallons of water per acre.
