

# NITRO GOLD™

## Product Information

**NitroGold 45** is a liquid foliar formulation designed for maximum uptake of Zinc, Manganese and Iron and should correct and prevent deficiencies in most citrus. If added to the spray tank first, it will aid in lowering water pH. A jar test to check the compatibilities of unfamiliar or new combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant and/or urea nitrogen will aid in uptake.

## Directions For Use

**NitroGold 45** should be applied at 2-6 quarts per acre in enough water to cover.

**Aerial application:** Use 1-3 quarts per acre in a minimum of 5 gallons of water per acre.

## Crop Recommendations

**Citrus and Fruit Crops:** Mature trees: Use 2-6 quarts per acre per application in enough water to allow for thorough coverage. Repeat application in summer and fall sprays as needed.

**Young trees:** Use 2 quarts per 100 gallons of water and wet to run off.

**Pecans:** Use 2-3 quarts per acre in enough water to cover.
