EXTINCT XL is a proprietary silicone antifoam emulsion designed for prevention or suppression of foam formation in aqueous solutions. The functional properties include quick dispersibility, slight insolubility, relative stability, and spreadability in ionic solutions.

EXTINCT XL is very aggressive in agricultural pesticide tank mixes, especially *ROUNDUP® ULTRA, offering antifoaming qualities when used in a premix or defoaming characteristics on already existing foam. All emulsifiers used in this formulation are non-ionic, offering superior uniformity and compatibility.

This product cannot be used for aquatic applications.

USE RATES

Use **EXTINCT XL** at 1/2 to 2 ounces per 100 gallons of solution. It may be necessary to adjust the amount used according to individual conditions.

NOTE: it is always best to add to tank mixture before foam has already formed.
