4. FIRST AID MEASURES

5. FIREFIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

In Case of Spill: Evacuate the spill area, except for cleanup personnel. Wear personal protective equipment (PPE). Control spill with adsorbent pads or booms. Dry material: Sweep up and place in an appropriate closed container. Wet material: Absorb with an inert absorbent (sand, earth, sawdust, etc.) to spill area and shovel into containers for disposal.

7. HANDLING AND STORAGE

Precautions to be Taken in Handling: Keep container sealed when not in use. Safety goggles and eyewash recommended. USDA-accepted nitrile (CFR-20) or neoprene rubber (CFR-21) recommended. Wear appropriate clothing to prevent repeated or prolonged skin contact.

Precautions to be Taken in Storage: Product should be stored in a dry place at temperatures between < 109°F. Do not store together with food, beverage and animal feed.

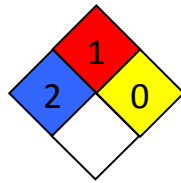
